- WHO:**
- 1 Owner with future Service Dog; includes attendance with 1 support person.
 - AGE of DOG: 4 months and up, must be well mannered with basic obedience.
 - Applications require a 2 to 5 minute video submission showing basic skills.
- WHAT:** A complete package designed by an ALBERTA GOVERNMENT QUALIFIED SCHOOL following the Alberta Training Standards to best prepare you for recognition as a government "Qualified Service Dog Team"

- HOW:**
- 1) Request an application form by e-mail: train@CanadianCanineTraining.com
 - 2) Submit application & short video with \$25 non-refundable fee (towards tuition)
 - 3) Applicants meeting prerequisites are then accepted as first come- first served
 - 4) 50% Tuition deposit to hold spot... Remaining amount due on first day of course
- WRAP-UP:**
- A) **"Ready" Teams:** Schedule a Qualification Assessment through CCT, completing the process. (Assessment fee included if qualifying during the fast-track pack program)
- B) **"Not Ready" Teams:** Continue the journey alone, or with CCT and acquire SD access rights to train in public, until your pup is 18 months, or you meet all the SD qualifying skills and tasks.
- C) **GRANT FUNDING** Consideration for continued SD training expenses covered under government grant funding directly through CCT can be initiated at this stage... Individuals going forward who do not qualify for grant coverage are given a 20% discount on continued training expenses. Estimated regular training fees are typically in \$400 increments for [5 private or 10 group sessions] depending on needs.
